**Brief business information of applicant**

Tanah Makmur Berhad began its involvement with oil palm plantation and the sale of Fresh Fruit Bunch since 1971 with its maiden plantation of 607 hectares. Presently, we have 13 plantation estates in State of Pahang, Malaysia with a total land area of 17,969.06 ha comprising 11,633.19 ha that we own and 6,335.87 ha of the LKPP-leased Land. We implement best estate management practice in order to strive for a high standard of productivity which also involves prudent cost control. Our four main activities in the oil palm plantation involved the Cultivation Process, Harvesting of FFB, Manuring and Weeding. Currently, all FFB produced and collected at our plantation estates are sold to our own palm oil mill and other third party traders and millers. We sell our FFB to external palm oil mills and traders via a tendering process to ensure better pricing to be achieved on our sales of FFB.
